This completed contract, along with a non-refundable/non-transferable deposit of \$100 is required to secure a booking.

Mobile petting farm (2hrs) additional hours \$150 per hour, Max 3 hours

Truck and trailer must be allowed to remain on site through the event, including set-up and Clean-up, or additional fee of \$50 will be assessed.

Set-up will begin approximately one hour prior to the event start time. Mobile enclosure can be erected on concrete, cement, asphalt or grass that has not been chemically treated within 30 days prior to event. Wood shavings are placed on all hard services. An additional charge of \$75 for covering is placed between surface and shavings. Events must conclude one hour prior to sunset, if adequate lighting is not available.

If petting farm enclosure is erected on grassy area, there will be minimal damage to grass/lawn/field due to nature of grazing animals. By initialing this statement the signer acknowledges and understands the above statement and will not hold the representatives, agents, volunteers or Danny's Farm liable for any and all damages as stated above.

Animal health and safety is our primary concern, price will not be adjusted due to unforeseen animal illness. We guarantee a minimum of five large animals at each event.

If the forecasted temperature is ninety-five degrees or above on the day of the event, the event will need to be rescheduled or cancelled for the health and safety of our animals. This will be a combined decision between acting petting farm manager and event coordinator.

#### **Mileage Fee**

Round trip mileage from Special Spirit 9889 Helen St., Sunland CA fee over twenty-five miles is as follows:

\$29 for 25.1-36 miles

\$58 for 36.1-47 miles

\$87 for 47-58 miles

#### **Damages**

Damages to petting farm area and/or mobile enclosures will be charged according to replacement value or repair cost as determined by a Foundation Official. No outside animals can be brought on premises (except for service animals with official identification) Unruly children and/or adults will be asked to leave at the discretion of the acting site manager.

#### **Clothing**

Close-toed shoes are recommended.

#### **Release of Liability**

The Group Release of Liability form (at end of this contract) is required to be signed prior to start of event. This form covers every person attending your event.

#### **Deposit of Payment**

\$100 deposit is due upon booking date. The balance is due prior to start of the event. All sales are final. No refunds or credits will be given with the exceptions of weather and/or natural disasters and at Danny's Farm discretion.

**Personal Property**

We are not responsible for lost or damaged personal belongings or gifts.

**Insurance**

Each party has policies of insurance of the type and in the amounts customarily carried by persons adequate to protect themselves against claims arising from and or associated with the activities conducted and or contemplated by this agreement. If the organization requires an endorsement there will be a fee of \$\_\_\_\_\_.

**Arbitration**

It is expected that both parties will make every effort to resolve any issue, conflict or dispute informally and equitably which may arise as a result of this agreement, and without the need for intervention by third parties, unless the parties agree that such intervention would assist in resolution of the issue, conflict or dispute. Both parties agree to participate in good faith in attempting any such resolutions. If informal resolution is unsuccessful, except for claims falling within the jurisdiction of small claims court, any and all disputes arising under or relating to the performance of the services contracted for under this agreement and any other claim arising under or relating to this agreement, shall be settled by arbitration in accordance with the applicable rules of the American Arbitration Association of any successor thereto. In the event the parties are unable to agree to a single arbitrator, the dispute shall be submitted to a panel of three arbitrators. Each party shall appoint an arbitrator and the two arbitrators so appointed shall then select a third arbitrator. Such arbitrator shall be final and binding upon the parties and shall be the sole exclusive remedy of the parties with respect to any dispute arising out of, relating to or resulting from the interpretation of the term of this agreement or its breach. The costs of such arbitration shall be allocated by the arbitrator under applicable law. Each party shall be responsible for its own attorney's fees, unless the arbitrator makes an award of costs and attorney's fees under applicable law.

**Indemnification:**

Organization shall indemnify, defend, and hold harmless the State of California, the Trustees of Danny's Farm, their employees, representatives, and agents from and against any and all claims, liability, loss, damage, demands, suits, judgements, expenses and costs (including without limitation costs and fees of litigation) of every nature arising out of or in connection with the Organization's performance hereunder or its failure to comply with any of its obligations contained in the agreement, except such loss or damage which was caused by the sole negligence or willful misconduct of the Foundation.

**Force Majeure:**

Foundation shall not be liable for any failure to perform as (required by this Agreement, to the extent such failure to perform is caused by any of the following: labor disturbances or disputes of any kind, accidents, failures of any required governmental approval, civil disorders, acts of aggression, acts of God, energy or other conservation measures, failure of utilities, mechanical breakdowns, material shortages, disease, or similar occurrences.
